## INFORMATION EX ART. 13 D. LGS. 196/2003 AND CONSENT

We inform you that pursuant to art. 13 of Legislative Decree 196/2003, your personal data will be processed exclusively for communication and promotion purposes in the context of the activities carried out by De Vecchi Milano 1935 Srl. Pursuant to art. 4, paragraph 1 letter. a) Legislative Decree 196/2003, "data processing" means any operation or set of operations carried out with or without the aid of electronic tools, concerning the collection, registration, organization, storage, consultation . modification, selection, extraction, comparison, use, interconnection, blocking, communication, dissemination, cancellation and destruction of personal data even if not registered in a database. Pursuant to art. 4, paragraph 1 letter. b) Legislative Decree 196/2003, "personal data" means any information relating to a natural person, legal person, organization or association, identified or identifiable, even indirectly, by reference to any other information, including a number of personal identification. Pursuant to art. 4, paragraph 1 letter. c) Legislative Decree 196/2003, by "identification data" we mean personal data that identify the direct identification of the interested party; Pursuant to art. 4, paragraph 1 letter. d) Legislative Decree 196/2003, "sensitive data" means personal data suitable for revealing racial and ethnic origin, religious, philosophical or other beliefs, political opinions, membership of parties, trade unions, associations or organizations of a religious, philosophical, political or trade union nature, as well as personal data suitable for revealing the state of health and sexual life; Data collection takes place by sending, by the interested party, an e-mail medium or using the methods provided for in this site, information relating to their personal data. The processing of personal data takes place using IT and / or telematic tools, however suitable for guaranteeing the security and confidentiality of the data in accordance with the provisions of the aforementioned Legislative Decree 196/2003, with logic strictly related to the purposes indicated and with methods that guarantee the security and confidentiality of the data, through the adoption of suitable measures pursuant to the law. The treatment will be based on the principles of necessity, correctness, lawfulness, impartiality and transparency; the data will be collected and recorded solely for the aforementioned purposes and your dignity, confidentiality, personal identity and your rights will be protected (and of the processing you will be given a response within the terms and in the manner provided for by art.10 of Legislative Decree 196 / 2003.). The data will be stored both in electronic archives, using web interfaced databases, and in archives not equipped with electronic tools, in order to minimize the risk of destruction or loss, even accidental, as well as unauthorized access or unauthorized processing, or does not comply with the collection purposes. Information about domains, IP addresses and other web identifiers found on our portal will be used only for internal traffic statistics and will in no way be accompanied by any personal information. Data processing will normally be carried out at the De Vecchi headquarters, by the person in charge of the processing of personal data or by specifically appointed persons. The provision of personal data by the interested party, for the aforementioned purposes, is optional.

Failure to provide personal data, however, makes it impossible to run the service to which this information refers. We also inform you that art. 7 Legislative Decree 196/2003, gives you specific rights, in particular: 1. The right to obtain the indication: 1. of the origin of the personal data; 2. the purposes and methods of the processing; 3. of the logic applied in case of treatment carried out with the aid of electronic instruments; 4. of the logic applied in case of treatment carried out with the aid of electronic instruments; 5. of the subjects or categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the State, managers or agents. 3. The right to obtain: 1. updating, rectification or, when interested, integration of data; 2. the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including data which need not be kept for the purposes for which the data were collected or subsequently processed; 3. the attestation that the operations referred to in letters a) and b) have been brought to the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except in the case in which this fulfillment is proves impossible or involves the use of means that are manifestly disproportionate to the protected right. 4. The right to object, in whole or in part: 1. for legitimate reasons, to the processing of personal data concerning you, even if pertinent to the purpose of the collection; 2. to the processing of personal data concerning him for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication. With regard to the exercise of the rights referred to in the aforementioned art. 7 of Legislative Decree no. 196/2003, as well as the methods of this exercise and the reply to the interested party, Articles 8, 9 and 10 of Legislative Decree 196/2003. The treatment will last no longer than necessary for the purposes for which the data were collected and in any case, unless otherwise specified, for a period not exceeding 24 months, without prejudice to the right to obtain early cancellation if it is not conservation is more necessary, pursuant to art. 7 Legislative Decree 196/2003. After the aforementioned period, the data will be destroyed. The ownership of the data processing, which is the subject of this information notice, belongs to De Vecchi Milano 1935 Srl, Via Goito 5, 20121 - Milan, in the person of the legal representative.
